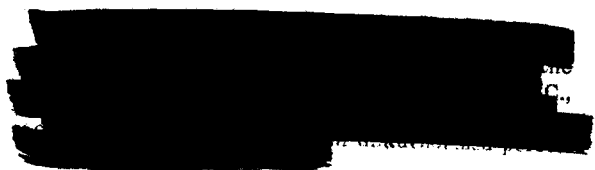

Commission Actions

1. AEC 449/43 - Agreement for Cooperation with the Government of Belgium - Approved. (Hall)
2. AEC 449/42 - Security Agreement with the Government of Belgium - Approved, subject to receipt of a satisfactory letter from the FBI. (Waters)
3. Canadian Security Practices - The comments of the FBI are to be requested on their adequacy. (Waters)
4. AEC 782/11 - Agreement for Cooperation with the Government of the United Kingdom. - Approval deferred, however, no points were raised.
5. AEC 782/12 - Security Agreement with the Government of the United Kingdom - The FBI is to be requested to make a comparison of this agreement with the Canadian Security Agreement. (Mitchell)
6. AEC 809/4 - Authorization Under Section 57(a)(3) to Provide Materials for Foreign Atomic Energy Programs - To be recorded that shipments to France were approved. (Price)

2. Briefing on Operation WIGWAM - Deferred indefinitely.
3. Letter to JCAE Regarding Mr. Lapp - Mr. Rolander has prepared a chronology for the Chairman.
