INFORMATION LIST FOR OBSERVERS AT OPERATION GREENHOUSE

1. Flight:

a. Special Air Mission aircraft, accompanied by a Tour Officer familiar with the general aspects of Operation "GREENHOUSE", will be scheduled to take observers from the MATS Terminal, National Airport, Washington, D. C., to the Marshall Islands. Each group of observers will proceed in two flights. It is planned that the first flight will leave two days prior to the second flight; the second flight is so arranged as to arrive in time for the scheduled program and to view the operations at Eniwetok. Two overnight stops are planned enroute; the first at Travis Air Force Base, California, and the second at Hickam Air Force Base, T. H. All flights are planned to be daylight and are approximately of nine (9) hours duration. Specific schedule and stop-over times will be provided separately.

b. In the event you are unable to join the flight in Washington, D. C., you may make arrangements through the Division of Military Application, USAEC to join the flight either at Travis Air Force Base, Fairfield Suisan, California or Hickam Air Force Base in Hawaii. Prior to your departure the Division of Military Application, USAEC will furnish you the name, office, and telephone number of personnel to contact on your arrival at these two places. They will render assistance in enabling you to join the flight at these two locations and in securing such other facilities as you may require.

c. Arrangements have been made to dispense with all formalities, and honors at Washington, D. C., Travis, and in Hawaii so that little or no attention will be drawn to your movement and that of other observers. The target date for each test is classified SECRET and the general time of all tests is CONFIDENTIAL. It is desired to stress the fact that your proposed trip should in no manner be connected with Operation "GREENHOUSE".

2. Items required prior to commencement of travel:

- a. "Q" clearance (processed by order issuing agency)
- b. Travel orders (issued by the inviting agency)
- c. Identification card (furnished by the order issuing agency)
- d. certificate of immunization or of receipt of a stimulating dosage within the last year against the following: (arranged in order issuing agency)

- (1) Smallpox
- (2) Typhoid fever
- (3) Tetanus

3. General Information:

a. Clothing - Light weight summer clothing will suffice during that portion of the trip from the West Coast to Eniwetok and return. Each person should anticipate his own needs and take such additional items as required. Following is a suggested list of special clothing and equipment that may be useful while at Eniwetok:

- (1) High and low quarter shoes.
- (2) Heavy cotton socks.
- (3) Towels (bath and face).
- (4) Hat, sun helmet, or cap with long visor.
- (5) Sun glasses.
- (6) Light rain coat.
- (7) Clothes hangers.
- (8) Bathing suit.
- (9) Khaki trousers and shirts.

b. Emergency contact - In event it is necessary that you be contacted, messages addressed as follows will be immediately forwarded: Test Activities Branch, Division of Military Application, USAEC, 1901 Constitution Avenue, Washington, D. C. (Phone: Sterling 8000, Ext. 607)

c. Checks - Personal checks cannot be cashed at Eniwetok Atoll, Marshall Islands, however, the following money instruments will be honored:

- (1) U. S. Treasury checks.
- (2) U. S. Postal Money Orders.
- (3) Travelers checks issued by:
 - (a) American Express Company.
 - (b) National City Bank of New York
 - (c) Bank of America
 - (d) National Trust and Savings Association, Mellon National Bank of Pittsburgh.

d. Charge of service and meals - While at Eniwetok Atoll there will be a daily charge of \$1.50.

e. Facilities available at Eniwetok - There will be a Post Exchange with standard items of stock, movies, club, library, swimming and other recreational activities.

f. Security regulations at Eniwetok list the following items as contraband and they will be confiscated at Security Control Points on arrival in the atoll area unless personnel are duly authorized such items in the execution of their duties:

- (1) Cameras (all types)
- (2) Films (all types)
- (3) Photo Lab Equipment
- (4) Private Firearms (all types)
- (5) Signalling Devices (signalling guns, sheilded flashlights, flares, and similar devices).
- (6) Field Glasses
- (7) Radio Transmitters
- (8) All weapons (small pocket knives excepted)
- (9) Fireworks (all types)
- (10) Intoxicants
- (11) Narcotics

g. Baggage - While traveling via military aircraft 65 lbs. of personal baggage is allowed. Each piece should be tagged with durable shipping tags, giving full name and address.

h. Inflight lunch charges - There will be a nominal charge for lunches served during the flight. The Tour Officer will collect from each individual after boarding the aircraft.

i. Travel order - Be prepared to furnish five (5) copies of travel orders to the Tour Officer on boarding the aircraft.
