1. BOATS AND SHIPS:

Received TWX from USS ARIKARA giving the estimated time of departure from BIKINI at 1000Z hrs 14 July 58. It will have the tow YCV-9 and proceed directly to ENIWETOK at a speed of 8 knots. Estimated time of arrival is 0900Z 15 July 58. (SEC)

2. MISCELLANEOUS:

a. At Col Pinson's request an itinerary was prepared and distributed to those concerned with the briefing of the Secretary of Defense and his party on 16 July 58. In addition to the briefing in CJTF7 conference room the party will visit the assembly bldg and Station 71. (JHW)

b. All arrangements have been completed for the support of Program 40 at and near RONGELAP during the period 12 - 24 August 1958. TG 7.5 has been requested to furnish the MV ALOTO (Via Support Work Order) and TG 7.4 has been requested to furnish communications and SA-16 support (Via Letter). Dr. Donaldson so notified. (JHW)

a. Arrangement were made with CDR Earl ^{Luehman} ~~Luehman~~ (TG 7.3 Operations) by CDR Wendell to transfer the OLIVE Shot Barge Via LSD-35 USS MONTICELLO from BIKINI to ENIWETOK on 17 July 1958. The LSD would depart BIKINI at 1300 hours if the JUNIPER event occurs in the AM of the 17th and at 180800M July if detonation occurs in the afternoon. J-3 BIKINI so notified. (JHW)

b. Today was PISONIA-3 and JUNIPER-2. (FAP)


