RESERVATIONS ON MAC, MAY 10, TO GO THROUGH KWAJALEIN TO ENIWETOK FOR:  
 DR. ALAN H SEYMORE, UNIV OF WASH SSH  
 SCHEDULE FROM KWAJALEIN AS FOLLOWS:

LEAVE KWAJALEIN, MAY 3, CHARTER AIRCRAFT (C-54) TO ENIWETOK. LIVE ABOARD LCU FOR EIGHT DAYS WHILE SURVEYING THE BIKINI ATOLL. LEAVE BIKINI BY LCU ON ABOUT MAY 10, FOR ENIWETOK, SURVEY PARTY AND 24 FOOT BOAT WILL BE DROPPED OFF. THE LCU THEN RELEASED FOR RETURN TO

KWAJALEIN. LIVING ACCOMMODATIONS PROVIDED BY SAM-TEC ON ENIWETOK MAY 10 OR 11 TO MAY 17. TRANSPORTATION ON ATOLL PROVIDED BY PACE AND OUR OWN 24 FOOT BOAT. THE BOAT WILL BE LEFT IN DRY STORAGE ON ENIWETOK.

TRANSPORTATION ON MAC FOR ABOVE PERSONNEL (9) REQUIRED FROM ENIWETOK TO KWAJALEIN MAY 17 THEN ON TO HONOLULU FOR ONE OR TWO. THE REMAINING SEVEN OR EIGHT WILL REQUIRE ACCOMMODATIONS ON KWAJALEIN MAY 17 AND 18, AND MAC TRANSPORTATION TO HONOLULU MAY 19.
