Dear Oscar:

Our plans are sufficiently well developed now to submit a firm schedule requesting use of your LCU, cargo ship and arrangements for plane support for our forthcoming survey. I believe these plans conform generally with our discussions in November. The dates in the below schedule are designated both for Trust Territory and Kwajalein (U. S.) time in order to avoid confusion.

Feb. 18	Feb. 17	LCU depart Majuro
Feb. 19	Feb. 18	LCU arrive Kwajalein
Feb. 20	Feb. 19	Onload LCU
Feb. 21	Feb. 20	LCU depart Kwajalein for Rongelap with advance medical group including Trust Territory personnel.
Feb. 22	Feb. 21	LCU arrive Rongelap, offload
Feb. 26	Feb. 25	Sea plane Majuro to Kwajalein to pick up five doctors and take them to Rongelap. At Rongelap, pick up Dr. Held and an assistant to take to Bikini.
March 9	March 8	Trust Territory ship arrive Rongelap, load ship.
March 10	March 9	Complete loading of ship, depart for Kwajalein, sea plane from Majuro to Rongelap as early in A. M. as possible to take five doctors to Uirik and remain there until late afternoon to take group to Kwajalein.
March 11	March 12	Ship arrive Kwajalein, offload medical equipment; depart from Majuro.
