3. Preliminary design, cost estimates, and reports providing management with information on which to plan for current or future scientific requirements.
4. Studies of past experience and methods to promote greater efficiency in planning future scientific facilities.
5. Development of standard specifications relating to construction of scientific installations.
6. Other general surveys, reports and studies concerning islands or areas used or to be used for scientific purposes.
7. Professional services, such as consultants, laboratory analysis, and other engineering services related to Scientific Program Planning Engineering.
