ABOUT SIX HOURS CONVERSATION WITH MLSC ATTORNEY ALLEN LEAVES ME WITH SOME APPREHENSION ABOUT A KILI TRIP, BUT DETERMINED TO GO AHEAD. ALLEN, DESCRIBING HIMSELF AS A HEAVYWEIGHT TRIAL LAWYER, IS FIRMLY CONVINCED THAT LITI-GATION WITH ERDA (OR SOME U. S. GOVT AGENCY) IS INEVITABLE. HE SEES HIS FIRST TASK AS ESTABLISHING HIMSELF WITH HIS CLIENTS AS THEIR ADVOCATE AND OUR ADVERSARY.

TO OTHERS THOSE WE CANNOT ANSWER. THE PURPOSE OF OUR VISIT, I HAVE STATED, IS TO SUPPORT DISTAD DEBRUM IN INFORMING THE PEOPLE OF BIKINI OF OUR CURRENT STATE OF KNOWLEDGE OF RADIOLOGICAL CONDITIONS AND TO PROVIDE ADVICE AS REQUESTED PERTAINING TO THEIR PLANS.
