PHASE II SURVEY STATUS REPORT NO. 3

BOTH HELICOPTERS OPERATIONAL NOV 10, RADIATION SORTIES COVERED FRED, ELMER AND DAVID ON A 150 FT GRID. POINT SOURCES OF CESIUM AND COBALT WERE OBSERVED ON FRED AND ELMER. GROUND RECONNAISSANCE ON ELMER TO FOLLOW UP POINT SOURCE LOCATION REVEALED WHAT APPEARS TO BE A COBALT SOURCE IN A DETERIORATED PIG IN TURN WITHIN A DOSIMETER CALIBRATION FACILITY. WE WILL DEVELOP A PLAN FOR RETRIEVAL AND PROBABLY ORDER OUT A NEW PIG FOR SHIPMENT TO LAS VEGAS.

BLACK & WHITE COVERAGE OF ALL ISLANDS COMPLETED. TWO OF SIX PHOTO BOOKS HAVE BEEN MADE AND WILL BE EXCEPTIONALLY VALUABLE IN LATER SURVEY PHASES. VERTICAL PHOTO MAPS HAVE BEEN USED FOR

NAVIGATION IN THE RADIATION SURVEY WITH EXCELLENT RESULTS.  
ALL ACTIVITIES STILL SUFFERING FROM WATER AND POWER SHORTAGE.  
NO FRESH WATER AT ALL IN LIVING QUARTERS. CARRIED WATER ONLY  
IN PHOTO LAB. DUE TO LACK OF AIR CONDITIONING, REPEATED COMPUTER  
FAILURES INTERRUPTED DATA PROCESSING MOST OF NOV 11 AND MORNING  
NOV 12. COMPUTER AND DATA PROCESSING ACTIVITY NOW MOVED TO MARIN  
DEPT. OFFICE WHERE RELIABLE POWER SUPPLIED BY COAST GUARD STA.

FUEL REPLENISHMENT DID NOT ARRIVE AS EXPECTED ON NOV 10,  
RESULTING IN MY 110530Z NOV 72 TO CINCPAC. NO FLIGHT OPS POSSIBLE  
NOV 11 AND 12. HOWEVER WE NOW APPEAR TO HAVE FOUND THE RIGHT BUTTONS  
TO PUSH AND EMERGENCY RESUPPLY FOR ONE DAY OPS ARRIVED 130330Z  
TO BE FOLLOWED BY FULL RESUPPLY 132100Z.
