Isl, monthly (BIKINI ISLANDERS RETURN TO NOME ISLAND DELAYED) Saipam, aug.23 (1988)----The Plannes Return in Mid-September OF THE PIRST OFFICIAL CONTINGENT OF SOME 450 BIKINIAMS TO THEIR HOME ATOLL HAS BEEN POSTPONED TO PERMIT COMPLETE ANALYSES AND EVALUATION OF THE LATEST RADIOLOGICAL SURVEY. IT WAS CONDUCTED IN JUNE 1975 BY THE ENERGY RESEARCH AND DEVILOPMENT ADMINISTRATION (ERDA) ON BIKINI ATOLL. Birini was the site of 23 nuclear tests (including surface AND SUB-GURFACE BURSTS) IN THE PERIOD 1946-50. THE BIKINIAMS were moved from biking atoll before testing began. They were Subsequently settled temporarily on kili island. Also in the Marshalls. If august, 1966, president joenson amnounced that THE BIKINIAMS WOULD BE ARLE TO RETURN TO THEIR HOMELAND AT A LATER Time. He directed the department of the interior, department of depense, and the atomic energy commission (now part of erda) to cooperate in preparing por their return.

TWO ISLANDS OF THE ATOLL, BIRENI AND ENEW, WERE DETERMINED IN 1967 TO DE SAFE FOR HABITATION WITE CERTAIN RESTRICTIONS NECESSARY FOR BIKINI ISLAND. SINCE THE PROPLE OF BIKINI ATOLL TRADITIONALLY HAD THEIR MAIN LIVING SETTLEMENT ON BIKINI ISLAND, THEY ELECTED TO HAVE THE NEW SETTLEMENT STARTED THERE WITH THE UNDERSTANDING THAT SOME RESTRICTIONS WERE NEEDED AND CONTINUAL RADIOLOGICAL CHECKS WERE TO BE MADE BOTH BEFORE AND AFTER THEIR RETURN TO THE ISLAND.

AS PART OF THE CONTINUING MONITORING OF BIKINI ATOLL A SURVEY COMDUCTED BY ERDA IN JUNE 1975, REVEALS THE PRECAUTIONARY MEASURES RECOMMENDED IN 1967 MAY REQUIRE MODIFICATION. A STUDY OF THE JUNE 1975 DATA IS UNDERWAY AND DEPINITIVE RECOMMENDATIONS ARE EXPECTED IN ABOUT SIX MONTHS FROM NOW.

THE DEPARTMENT OF THE INTERIOR, WITH PRIMARY RESPONSIBILITY FOR THE TRUST TERRITORY OF THE PACIFIC ISLANDS OF WHICE BIKINI ATOLL IS A PART, HAS BEEN CONSTRUCTING THE PIRST PHASE OF THE NEW SETTLEMENT ON BIKINI ISLAND. THE DEPARTMENT RECOMMENDED THIS WEEK THAT THE FIRST OFFICIAL CONTINGENT WAITING ON RILL SHOULD DELAY THEIR MOVE PENDING FURTHER ANALYSIS OF THE RECENT RADIOLOGICAL SURVEY.
