1. It is noted with pleasure that USS MONTICELLO has accepted:

(a) 33 pallets/21,455 pounds/1,625 cubic feet/41 measured tons of Handclasp material for delivery to Eniwetok.

(b) 116 pallets/96,105 pounds/5,750 cubic feet/144 measured tons of Handclasp material for delivery to Kwajalein.

2. The cooperation of all those involved in arranging space and loading of this material is sincerely appreciated. Of particular note was the efforts of Lieutenant Junior Grade J. R. Moore. It is this type of "can do" spirit that ensures the timely delivery of greatly needed Handclasp materials to major overseas commands for distribution to hospitals, clinics, universities, etc., where they can provide the greatest benefit.



Encl: (1) Seven Transportation Control and Movement Documents (TCMD'S) ENI-053-78 thru ENI-058-78 and ENI-066-78 (2) Description of medical supplies

1. Enclosure (1) contains copies of shipping documents for 33 pallets/ 21,455 pounds/1,625 cubic feet/41 measured tons of Project Handclasp (PH) material placed on board USS MONTICELLO (LSD-35) in San Diego in March 1978 for delivery to Eniwetok.

2. The value of this shipment is estimated conservatively at \$32,000. No value can be placed on the efforts and goodwill of persons and/or companies who collected and donated this material. Inasmuch as this represents a trust in the Navy by persons donating this material, it is of utmost importance that all possible steps be taken to safeguard the shipment from damage, loss, or pilferage. It is requested that close attention be paid to the documents during off-loading and distribution, and that the Transportation Control Number be compared on the documents and on the pallets. (Identifying information is marked on the top of each pallet.) In addition, it is important that the command representative is present when Handclasp material is off-loaded. Normal supply procedures should be used, including a physical inventory of the material, a signed receipt being retained whenever the material is turned over to another activity, etc. All Handclasp material requires covered/secure storage.

3. Background information concerning preparation and applicability of a few of the items listed in enclosure (1) follows:

(a) Three pallets medical supplies. Two pallets containing approximately \$2500 of assorted Johnson and Johnson (J&J) supplies. See item a, enclosure 2. One pallet consisting of two Phase I Medical Kit. See item b, enclosure 2.

(b) Two Project Handclasp Sewing Machine Workshops. Each triwall contains a new treadle sewing machine, 50 yards of material, scissors, assorted buttons, needles, thread, and other sewing notions as well as Band-Aids, Tang, diapers etc., used as fillers. This workshop is very valuable in that it gives an enterprising recipient the capability of

beginning a self-sustaining profession as well as maintaining clothing for his own family. It is important that this workshop be given to a recipient who will put it to good use, and that feedback from the command and/or the recipient be forwarded to the donor listed on the document.

Note: Dental floss (although contained in medical kits) can be used for sewing purposes. PH has been advised that it makes an excellent thread substitute for jobs requiring a tough, strong, thread, such as sewing leather.

(c) Four pallets of used school desks. It is requested that these desks be assembled and renovated before distribution.

(d) Three pallets of water cans. Sufficient dual inserts are provided for use of these cans as water containers. If painted white, and provided with handles, these cans also make excellent disposal cans for use in hospitals and clinics. Other uses include food storage, waste receptacles, etc.

-(e) Five pallets of chicken/crackers, four pallets of jam/crackers, five pallets of crackers, and one pallet Contadina tomato sauce. Each pallet of crackers contains approximately forty 15-pound hermetically sealed cans.

(f) Three pallets of sanitation kits. Each pallet contains 18 portable toilets.

(g) One pallet of mixed flower and vegetable seed. Contains approximately 15 boxes, 7,500 packages of seeds.

(h) Two pallets books. Each pallet contains approximately 800 elementary schoolbooks.

4. Two bolts of material, each containing 806 square yards of muslin fabric, were shipped to Kwajalein on TCMD #KWA-065-78. One bolt to be forwarded to Eniwetok by Mr. Robert E. Haley, phone Kwajalein 82103. TCMD #ENI-066-78 refers.

5. Project Handclasp provides material to those commands which have expressed the greatest interest, including maximum participation, effective distribution, and feedback. No donor, whether individual or corporate, will continue to provide material to Project Handclasp or any similar organization without being apprised of how their material has been utilized and the results obtained from this utilization. Therefore, it

is important that feedback be forwarded. Correspondence concerning the distribution, value, acceptance, etc., of specific products is requested. In addition, correspondence discussing the command's observation of the impact of the program should be sent to West Coast Director, Project Handclasp. Pictures obtained during the distribution (both black and white, with negatives, and color slides) are also highly desired. It is through this type of feedback that Project Handclasp is able to obtain the materials available for overseas commands.

6. Please be assured that your efforts in handling this material are deeply appreciated and that your involvement will contribute significantly to furthering the U. S. Navy's people-to-people program in the western Pacific.
