SHELTERS NAMELY THE JATO MAGAZINE ON FRED AND THE IBM BUILDING ON PARRY PD THE MAGAZINE IS A REINFORCED CONCRETE STRUCTURE CMM IGLOO TYPE CMM WITH SIX INCH THICKNESS AT TOP TAPERING TO SIXTEEN INCHES THICKNESS AT THE BASE PD ADDITIONALLY IT HAS BEEN COVERED WITH A TWO INCH STEEL PLATE PLUS ONE FOOT OF EARTH PD THEY CONSIDER IT ONE HUNDRED PERCENT SAFE PD THE IBM BUILDING IS REINFORCED WITH EXTERIOR WALLS ONE FOOT THICK PD THE ROOF IS REINFORCED CONCRETE SLAB EIGHT INCHES THICK PD THEY CONSIDER THIS STRUCTURE IN ALMOST THE SAME SAFETY CATEGORY AS THE MAGAZINE PD CAPT PARKS STATED THAT ALL PEOPLE NOT ESSENTIAL TO THE OPERATION PROPER WOULD BE REQUIRED TO TAKE SHELTER AND THAT THEY WOULD HAVE NO OPTION TO DO OTHERWISE PD HE EXPRESSED THE BELIEF THAT EVACUATION SHOULD NOT BE NECESSARY AND ASSURED THAT THE SHELTER SPACE PROVIDED WAS AMPLE FOR ALL RESIDENTS PD END REF TA CLN VWL-2643
