Dear Ted,

Our survey schedule is still not completely firmed up because of the Bikini end. If I can get the O.K. of the Trust Territory to allow the Japanese television group to transit Enue, the LCU could go there from Rongelap and the Army plane pick the medical group (minus 3) and the TV group and take them back to Kwajalein. I would have a few hours on Bikini to talk to the people. We had scheduled this plane for Monday, April 5th. If it is not possible to get such a flight on a week day we can alter our schedule for the plane to come in on Sunday, April 4th. Please let me know about this.

Were you able to get the 6 bunks back in the counter trailer? If there is not a refrigerator in that trailer would it be possible to put one in for the survey? We would like to store drugs and blood samples in it.

We will have about 20 boxes to go on the LCU. One conex should suffice? We have been considering bringing our tractor (bulldozer) at Rongelap back to Kwaj. for overhaul. We can also use it at Enue to get our boxes ashore and loaded on the plane. Will there be room on the tank deck for the tractor? If necessary we could probably leave the jeep at Kwaj. But maybe there is enough room for both. Please let me know. The following food purchases are required:

- Rice - 350 lbs (50 lb. sacks)
- Sugar - 120 lbs (260 lb. sacks)
- Donut flour - 200 lbs (2 100 lb. sacks)
- Crisco - 24 (3 lb. cans)
- Kool-Aide - 576 envelopes (sweetened)
- Cokes - 5 cases
- Cheese - peanut butter crackers (small packages) 1 gross.
- Cookies - (small packages) 1 gross.
- Apples - 5 cases
- Oranges - 5 cases

The cokes, crackers and cookies are for Ebeye use. The food for the LCU can probably be stored in the counter trailer. Doug Clareus can help you get this all together when he arrives.
