REFERENCE MY DTG 221643Z AND 221740Z, STATE DEPARTMENT ADVISES ME THAT THEY HAVE REVIEWED SITUATION AND THAT IN VIEW OF OUR OFFER TO THE GOVERNMENT OF JAPAN AND THEIR PLEASED ACCEPTANCE THEREOF, THAT WE SHOULD GO THROUGH WITH THE SENDING OF THE MEDICAL AND TECHNICAL TEAM TO RABUAL. GOVERNMENT OF JAPAN AND CONCURRENCE OF AUSTRALIAN GOVERNMENT ACTION  
CONCURRENTLY BEING TAKEN THRU US EMBASSY CANBERRA FOR CLEARANCE.  
THERE HAS BEEN NO TIME FOR ME TO HAVE RECEIVED ANSWER AS TO MY QUERY  
GENERAL LUEDECKE'S CAPABILITY TO RADIO PORT MORESBY. HOWEVER, THIS  
MESSAGE CONSTITUTES AUTHORITY AND DIRECTION TO DISPATCH FLIGHT  
RABUAL. SUBJECT TO CLEARANCE FROM ADMINISTRATOR. IN VIEW OF  
LESSER URGENCY IN SITUATION REQUEST NO UNNECESSARY RISK BE TAKEN  
SUCH AS FLYING INTO RABUAL AT NIGHT IF IN GENERAL LUEDECKE'S JUDGEMENT;  
THIS IS INDEED UNNECESSARY RISK. IN ADDITION TO INFORMATION  
REQUESTED IN MY 221643Z, REQUEST YOU INFORM ME OF TYPE AIRCRAFT  
AND ROUTE PLANNED. THAT IS, DIRECT OR THROUGH TRUK. DOD/GENERAL  
LOPER/ HAS BEEN INFORMED OF THIS MESSAGE AND CONCURS IN DIRECTIVE  
CONTAINED HEREIN
