GREENHOUSE FROM THE ENVIRONMENTAL SIDE OF BROOKHAVEN WILL CONDUCT IN VIVO COUNTS ON FORMER RESIDENT OF BIKINI NOW LIVING ON MAJURO AS PART OF DOE'S FOLLOW UP COMMITMENTS TO THE BIKINIANS. HARRY BROWN OF MY STAFF WILL ALSO ARRIVE MAY 13 TO CONTINUE HIS WORK ON RONGELAP-UTIRIK PER DIEM CLAIMS UNDER THE NOW EXPIRED TTPI AGREEMENT, AND THE PROPOSED NEW AGREEMENT NOW IN THE TTPI FOR REVIEW AND SIGNATURE. AS A DEPARTMENT OF ENERGY REPRESENTATIVE HE WILL BE AVAILABLE, AS WILL THE BROOKHAVEN PARTY CHIEFS, TO MEET WITH YOU, YOUR STAFF OR THE NITAJELA AT ANY MUTUALLY CONVENIENT TIME TO PROVIDE PROGRAM INFORMATION AND TO RECEIVE ANY INPUT YOU MAY HAVE.

3. ROGER RAY IS ALSO PLANNING TO BE IN MAJURO FOR ABOUT TWO DAYS DURING THIS TIME FRAME AND WILL COORDINATE WITH YOU ON MATTERS OF MUTUAL INTEREST.

4. WE LOOK FORWARD TO MEETING WITH YOU DURING THIS PERIOD AS YOUR SCHEDULE MAY PERMIT, AND HOPE TO CEMENT OUR RELATIONSHIP AS WE WORK TOGETHER IN THE YEARS AHEAD.
