FIRST MAJURO REPORT

THE DOI PRESS RELEASE OF AUG 23 REGARDING BIKINI HAS HAD
A SEVERE AND WIDE RANGING IMPACT. NOTE A MICRONESIAN
NEWS SERVICE RELEASE, SAIPAN DATELINED AUG 29. MITCHELL,
DIRECTOR OF MLSC IS QUOTED AS TERMING "DOUBLY TRAGIC" THE
"ERDA. . . CALLED FOR . . . DELAY BECAUSE LEVELS OF RADIOACTIVITY IN SOME AREAS OF BIKINI ARE HIGHER THAN FEDERAL
RADIATION STANDARDS."

IT IS WIDELY UNDERSTOOD HERE, BOTHOFFICIALLY AND PUBLICLY,
THAT ERDA DID INDEED CALL FOR THE 6 MONTH DELAY. THIS, IN
THE OPINION OF DISTAD DEBRUM DERIVES FROM AN EXCHANGE AT
THE AUGUST 12 LIVERMORE MEETING INVOLVING PRINCIPALLY DEBRUM,
MLSC LAWYER ALLEN AND DR. BILES. BILES IS SAID TO HAVE BEEN
ASKED WHAT ACTION HE WOULD TAKE WITH PRESENT KNOWLEDGE OF
BIKINI IF THE 40 HOUSES ON BIKINI ISLAND HAD NOT ALREADY BEEN
CONSTRUCTED. HIS ANSWER IS UNDERSTOOD TO HAVE BEEN THAT
HE WOULD "QUARANTINE" BIKINI ISLAND.

WHETHER OR NOT THE ABOVE IS PRECISE OR IN CONTEXT, IT IS THE SINGLE MOST DISTURBING IMPRESSION TO THE BIKINIANS.

THIS LEAVES DEBRUM REALLY NO CHOICE BUT TO DISCOURAGE OR
DENY USE OF THE BIKINI HOUSES. I BELIEVE THAT TO BE UNWARRANTED AND BILES COMMENTS TO HAVE BEEN MISINTEPRETED.
I AM SURE THAT WE CAN AND SHOULD CONVEY TO DEBRUM ET AL
THAT WE HAVE AMPLE KNOWLEDGE TO ASSURE THEM THAT THE
EXISTING HOUSES CAN BE SAFELY INHABITED, UNDERSTANDING,
OF COURSE, THAT THE DIET NOW IS AND SHOULD CONTINUE TO BE
FROM IMPORTED SOURCES, AND GROUND WATER MUST REMAIN
SUSPECT.

THE SIX MONTH DELAY MAKES NO SENSE AT ALL TO ME. THERE
ARE SOMETHING OVER 100 KILI PEOPLE READY TO RETURN AND
INHABIT BIKINI HOUSES. SIX MONTHS FROM NOW NOTHING WILL HAVE
CHANGED EXCEPT THAT WE WILL KNOW A BIT MORE ABOUT FOOD
CHAIN CONSIDERATIONS. BUT THE FOOD CHAIN IS NOT AT ISSUE FOR
EARLY UTILIZATION OF THESE HOUSES.

I HAVE TOLD DEBRUM THAT WHAT I THINK BILES INTENDED TO CONVEY
WAS THAT IF NO HOUSES EXISTED ON BIKINI HE WOULD NOT SUGGEST
PUTTING THE FIRST RESETTLEMENT COMMUNITY THERE; THAT WE
WOULD STRONGLY ENCOURAGE THE FIRST SETTLEMENT ON ENYU AND

AND CONTINUE TO STUDY BIKINI. IF BILES WERE TO SO CLARIFY
HIS REMARKS I BELIEVE DEBRUM WOULD, IN THE ABSENCE OF
DOI INSTRUCTION TO THE CONTRARY, PROCEED WITH RESETTLEMENT TO THE CAPACITY OF THE PRESENT HOUSES. AND WATER
CATCHMENTS. HE HAS ASSURED ME THAT EXISTING TERRESTRIAL
FOODS CAN BE KEPT OUT OF THE DIET. I URGE A BILES CLARIFICATION BY RETURN TWX.

OUR DISCUSSION WITH KILI PEOPLE WILL BE CENTERED AROUND THREE THEMES:

- 1. WITH SOME REASONABLE CONSTRAINTS, EXISTING HOUSES ARE ENTIRELY SAFE FOR HABITATION.
- 2. WE STRONGLY URGE AND ENCOURAGE A SHIFT OF EMPHASIS IN LONG TERM COMMUNITY PLANNING FROM BIKINI TO ENYU.
- 3. WE WILL CONTINUE RESEARCH, MONITORING AND SURVEILLANCE
 AND SHOULD, STARTING ABOUT SIX MONTHS FROM NOW, BE ABLE
 TO START ADVISING ON BIKINI ISLAND FOOD ITEMS. HOWEVER,
 WE DO NOT ANTICIPATE FOR SOME YEARS THAT BIKINI ISLAND
 WILL PRODUCE ACCEPTABLE SUBSISTENCE CROPS.

IN ADDITION TO THE REQUESTED CLARIFICATION OF DR. BILES

COMMENTS (PLEASE ADDRESS ME CARE OF DISTAD DEBRUM WITH

COPY CARE OF CMDR KMR) WE NEED AS SOON AS POSSIBLE TO KNOW

WHETHER IN FACT A DECISION HAS BEEN MADE TO DELAY BIKINI
RESETTLEMENT. I AM NOT AWARE THAT ANY SUCH POLICY DECISION
HAS BEEN COMMUNICATED TO DEBRUM. IF THERE HAS BEEN SUCH
A DECISION, I RECOMMEND IT BE REVERSED. IF THERE HAS NOT,
THEN WE SHOULD BE AUTHORIZED TO CORRECT THE RECORD BY A
PRESS RELEASE FROM HERE. DISTAD DEBRUM CONCURS.
