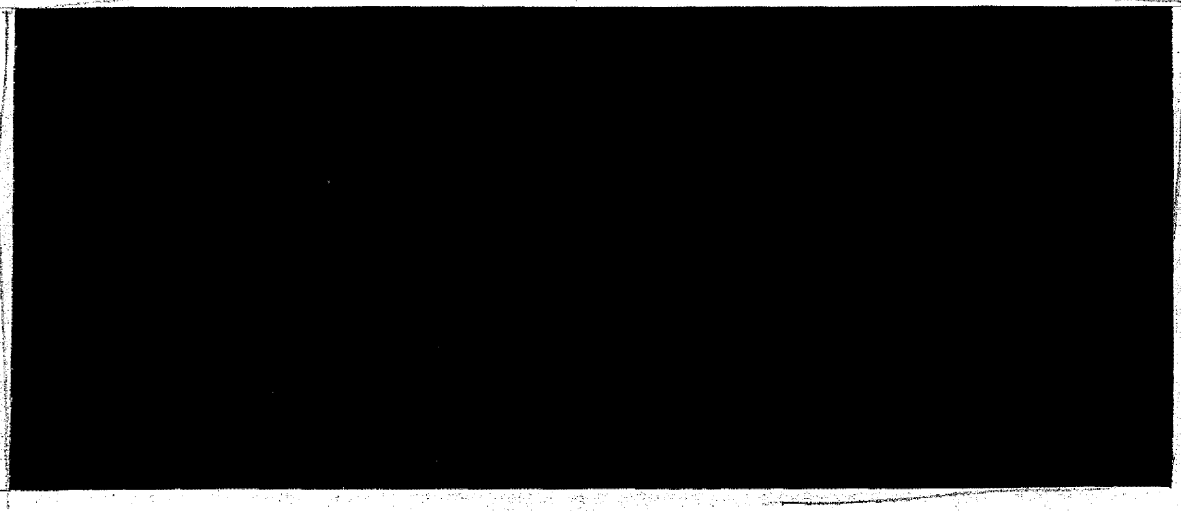

1. As a result of preliminary evaluation of RANGER data, the Director, Los Alamos Scientific Laboratory, has, by teletype dated February 21, 1951, recommended:

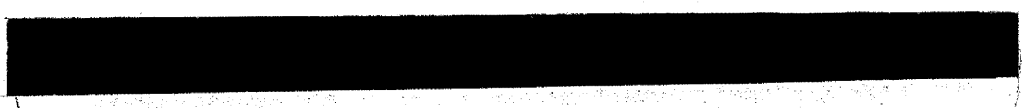

2. The Division of Military Application concurs with this recommendation. It should be noted that GREENHOUSE plans include emergency capabilities for either a tower shot or an air drop with RANGER-type ground instrumentation and air collection of samples for radiochemical analysis.

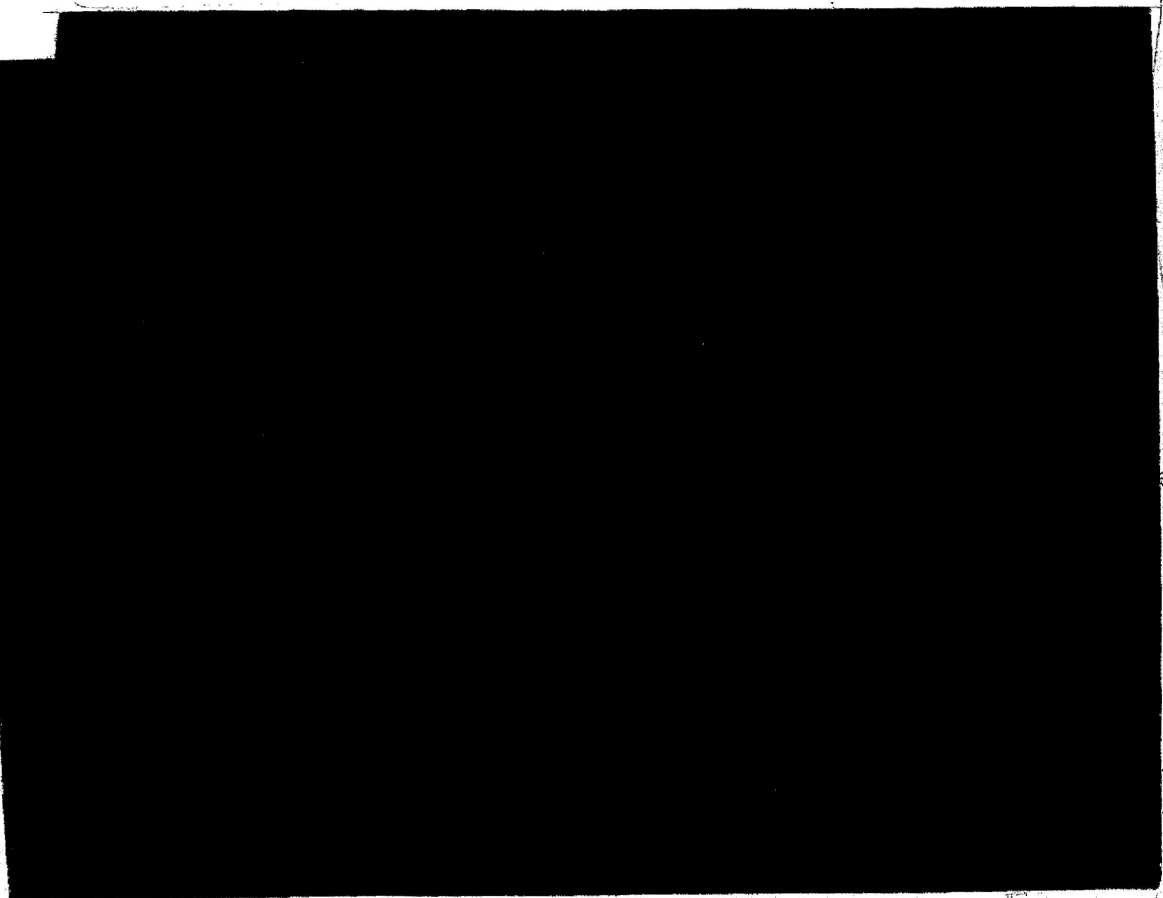

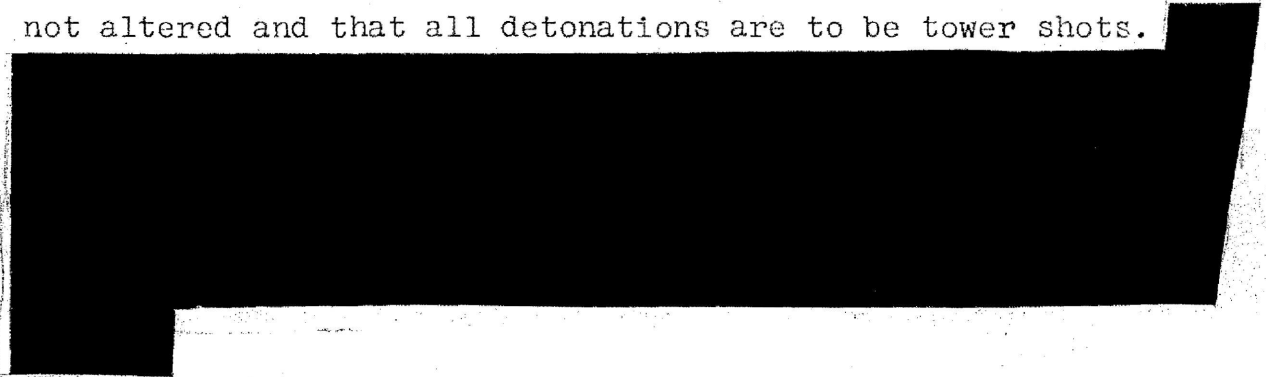
