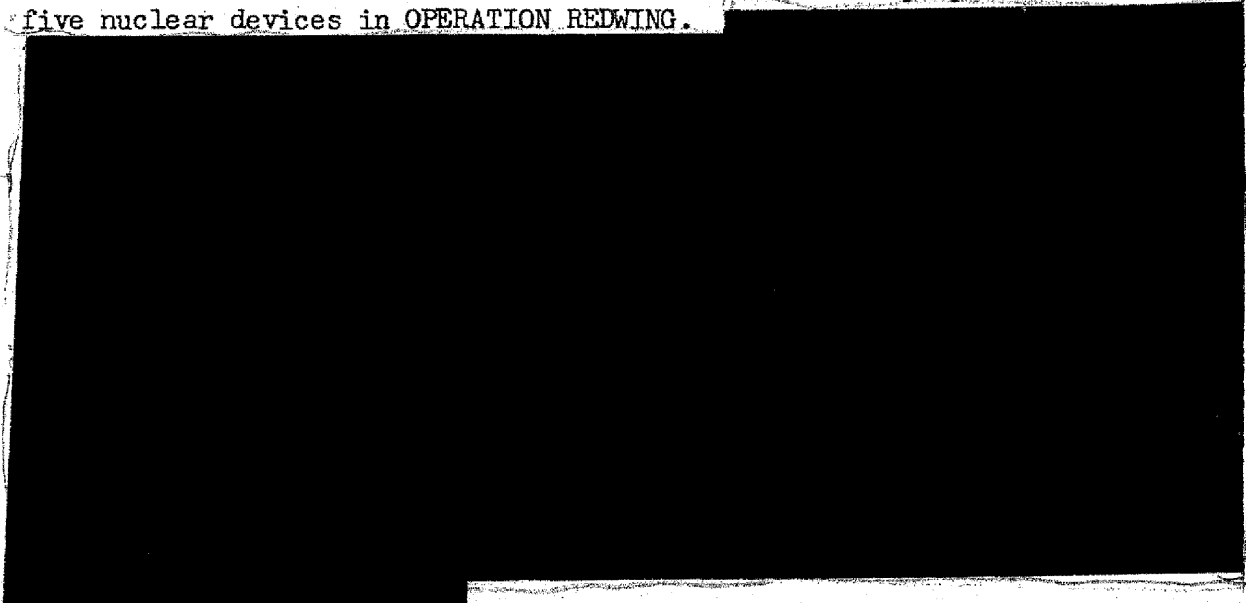

You will find below a preliminary discussion of the University of California Radiation Laboratory plans for Operation Redwing. The general outline of these plans is firm, but some changes in detail must be expected. No summary of special nuclear material requirements is possible at this time.
