SUPPLEMENTAL AGREEMENT

THIS SUPPLEMENTAL AGREEMENT, entered into this 15th day of March 1946, by and between the UNITED STATES OF AMERICA (hereinafter called the "Government"), represented by the Contracting Officer executing this agreement and THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a California corporation (hereinafter called the "Contractor"),

WITNESSETH THAT:

WHEREAS, on the 20th day of April, 1943, effective as of the 1st day of January, 1943, the parties hereto entered into Contract No. W-7405-eng-36 for the procuring and furnishing the necessary personnel, supplies, materials, equipment and performing such other services as shall be directed by the Contracting Officer or his authorized representative, and conducting certain studies and experimental investigations; and

WHEREAS, said contract has been modified by Supplemental Agreements Nos. 1 to 10, inclusive; and

WHEREAS, it is to the best interest of the Government to modify said contract as hereinafter provided; and

WHEREAS, this Supplemental Agreement is authorized by the First War Powers Act, 1941, and Executive Order No. 9001.

NOW, THEREFORE, said contract, as previously modified is hereby further modified in the following particulars, but in no others:

1. Add the following section to Article I, General Statement of Work and Services:

"3. The Contractor agrees to furnish such of its personnel as shall be mutually agreed upon between the parties hereto, for the purpose of having said personnel render such services in connection with the 'Crossroads Project' as shall be required by the Contracting Officer."

2. Add the following paragraph to Section 1 of Article V, Cost of the Work:

"p. If any of the personnel furnished by the Contractor in accordance with Section 3 of Article I shall be required to travel, the Government will reimburse the Contractor for the transportation of such personnel including pullman fare where necessary and will allow for such travel Six Dollars (\$6.00) per day in lieu of all other expenses; transportation by automobile on such required travel shall be reimbursed at the rate of five Cents (\$.05) per mile as representing the actual cost of such transportation; provided however, that if any of such

personnel shall be required to travel outside the continental limits of the United States, the Government will provide such personnel with transportation and quarters, and in addition thereto, the Government will allow for such travel Seven Dollars (\$7.00) per day in lieu of all other expenses. All travel shall be either authorized or approved in writing by the Contracting Officer."

3. Add the following paragraph to Article XXIV, Definitions:

"4. 'Crossroads Project' as used herein shall be deemed to include all activities of the Joint Chiefs of Staff of the Army and Navy Departments relative to the tests of the Atomic Bomb against Naval vessels in the Marshall Islands during the ~~year 1946~~ life of this Agreement but not beyond December 31, 1946."
