Operation Order CTG 7.1 No. 1-54 (Interim Phase)

1. General:

- a. This plan is based upon CJTF SEVEN Operation Order No. 2-54 (Interim Phase Operation Order) dated 7 May 1954.
- b. This Operation Order covers that period between the completion of the CASTLE operational phase and the beginning of buildup for the subsequent overseas test. (REDILE, scheduled for the Spring of 1956)
- c. By authority of the JCS, Commander Joint Task Force SEVEN exercises operational control of this Task Group for planning and coordination only during this interim period. "Operational control for planning and coordination" is defined as such authoritative direction in planning and preparation as is necessary to insure successful accomplishment of the joint task force mission.

2. Mission: This Task Group will:

- b. Continue analyses of tests and experiments and complete technical reports of Operation CASTLE.
- c. Continue operation with a view toward maintaining a test organization for Operation Radwing, with headquarters at Los Alamos, New Lexico.
 - d. Complete the non-technical photography mission for CASILE.
- e. At the earliest appropriate time, submit to CJTF SEVEN, the scientific and preliminary operational aspects of the concept for Cyer. 11. REDNING.

3. Tasks for Subordinate Units:

- a. <u>TU-1; TU-7; TU-9</u>: (Other Task Units are disestablished or inactivated)
 - (1) Complete those portions of the task group mission for Operation CASTLE as pertain to each task unit.
 - (2) Initiate planning and preparation for REDJING in same of the missions stated above.
 - (3) Submit reports and coordinate plans through normal ... group administrative channels.



Task Organization: Annex A

1. GENERAL:

a. Scope of Instructions:

- (1) This operation order covers that period between the completion of the CASTLE operational phase and the beginning of build-up for the subsequent test (REDVING, scheduled for the Spring of 1956).
- (2) "Forward Area" is defined as that area encompassing the MARSHALL ISLANDS.
- (3) "Closed Area" is defined as including the land areas of ENIWETOK and BIKINI ATOLLS, the water areas of the lagoons and the water areas within three (3) miles to the seaward side of each land area. The BIKINI Closed Area will be established to provide for safety of transient personnel. The Task Force will not be required to maintain its status as a Closed Area.

b. General Situation:

- (1) Commander Task Group 7.2 (CTG 7.2) assumes the responsibilities of Atoll Commander, ENIWETOK (ATCOM) upon departure of Commander, Joint Task Force SEVEN (CJTF SEVEN) and major elements of the Task Force from the Forward Area.
- (2) Upon departure of CJTF SEVEN and major elements of JTF SEVEN from the Forward Area, and upon completion of the operational phase of CASTLE, ATCOM is relieved of responsibility for the general security of BIKINI ATOLL, retaining responsibility to Commander-in-Chief Pacific (CINCPAC) for the general security of the Closed Area of ENIMETOK ATOLL.
 - (3) Intelligence, Security and Public Information: Annex C
 - (4) Friendly Forces:
 - (a) Elements of all Armed Forces of JTF SEVEN in the

Forward Area.

- (b) United States Army Pacific.
- (c) United States Pacific Fleet.
- (d) United States Air Force Pacific (when activated).
- (e) Military Air Transport Service.
- (f) Military Sea Transportation Service.
- (g) Marianas Bonins Defense Command.
- ,

(h) Philippine Command (U.S.).

- (i) Hawaiian Defense Command.
- (j) Personnel of the AEC, its contractors, sub-contractors and other participating agencies in the Forward Area,

2. MISSION:

- a. Upon departure of CJTF SEVEN from the Forward Area, discharge the responsibilities of CJTF SEVEN as ATCOM in accordance with CJTF SEVEN Operation Order No. 2-54 and CINCPAC General Emergency Operation Plan (GEOP) No. 11-53.
- b. Exercise direction of all JTF SEVEN Armed Forces based at ENIMETOK ATOLL for movement control, logistic support, general security and in pursuit of other duties of ATCOM as outlined in this order.
- c. Re-establish the Forward Area garrison and provide base facilities (except POL and fire fighting facilities) for tenant units and Armed Forces therein.
- d. Provide for the security and ground defense of $\mathtt{ENIWETOK}$ ATOLL.
- e. Operate and maintain base type military communications facilities and provide those signal services as shown in Annex D.
- f. Provide all radsafe functions for ENINETOK ISLAND, Annex Ξ_{\bullet}
 - g. See summary of tasks, Annex B.

3. TASKS FOR SUBORDINATE UNITS:

- a. Headquarters and Headquarters Detachment, 7126 AU: Provide overhead administrative and operational support for TG 7.2.
- b. Service Detachment, 7126 AU: Provide overhead logistical support to TG 7.2.
 - c. Military Police Detachment, 7126 AU:
 - (1) Establish MP posts as required.
- (2) Conduct security patrols and island sweeps within ENIWETOK ATOLL as outlined in Annex C.
- d. Signal Detachment, 7126 AU: Operate and maintain military communications facilities at ENIMETOK ISLAND exclusive of those operated by Airways and Air Communication Service (AACS).
- e. Truck Detachment, 7126 AU: Operate and maintain the ENIMETOK consolidated motor pool.
- f. Port Detachment, 7126 AU: Provide personnel for steve-doring and port operations.
 - g. Navy Detachment, (Boat Pool):
- (1) Provide marine support and related functions to CTG 7.2 as required.

 - (1) Accomplish missions outlined in CJTF SEVEN





SUMMARY OF TASKS, CTG 7.2


ARMY TASK GROUP:

1. SECURITY:

- a. Upon departure of CJTF SEVEN from the Forward Area, discharge the responsibilities of Atoll Commander, ENTWETOK (ATCOM) in accordance with CINCPAC General Emergency Operation Order No. 11-53.
- b. Report to CINCPAC for the purpose of general security with respect to the Task Force elements in the Forward Area and to ENIVETOK ATOLL. In this connection, CTG 7.2 will:
- (1) Maintain the status of ENIWETOK ATOLL as a Closed Area.
- (2) Within the capability of the forces available, deny entry into the ENT.ETOK Closed Area to unauthorized vessels and aircraft.
- (3) Deny entry of those personnel into ENIWETOK ATOLL not cleared for entry in accordance with CINCPAC instructions. (CINCPAC Serial 020 dated 1 April 1952, subject: "Eniwetok Atoll; Security Instructions").
- (4) Within the capability of the forces available, provide for the general surveillance of ENTYETOK ATOLL to insure against removal of significant samples from the shot islands, unauthorized photography and trespassing.
- c. Prepare emergency plans for the defense of ENIWETOK ATOLL, particularly ENIWETOK and PARRY ISLANDS, coordinating with the AEC representative on ENIWETOK ATOLL all plans for the disposition of AEC contractor personnel and the destruction of classified matter.
 - d. See Annex C.

2. PORT AND CAMP FACILITIES:

- a. Operate and maintain the communications facilities as outlined in Annex D.
- b. Provide personnel services for the garrison to include mail, military pay, religious activities, special service activities, clubs, army exchange, welfare activities and ENT. ETOK ISLAND bus service.
- c. Provide stevedoring labor and stevedoring equipment for loading and offloading supplies and equipment from ship to shore.
 - d. Provide onshore cargo handling on ENTMETOK ISLAND.
 - e. Operate and maintain a consolidated motor pool.
- 3. Report to CINCPAC for movement control in accordance with CINCPAC Serial 020, dated 1 April 1952.
- 4. Organize and develop a radsafe organization to accomplish the missions enumerated in $\Lambda nnex\ E_{\star}$
 - 5. Prepare natural disaster plans appropriate for execution Deplessified DOD DIR 5200.10

the event of typhoon or tidal waves, coordinating with the AEC representative on ENIWETOK ATOLL all plans for the disposition of AEC contractor personnel and the protection of classified matter.

NAVY DETACHMENT:

- l. Operate a boat pool consisting at a minimum of 2 LCMs, 2 LCPLs and 1 AVR.
 - 2. Support the 4930th TSG in sea, air rescue (SAR) operations.
- 3. Provide small boat support for port operations, atoll security and such other marine operations as may be required by CTG 7.2.
- 4. Prepare to implement on order CTG 7.2 Natural Disaster Defense Plan No. 3-54 and CTG 7.2 General Emergency Operation Plan No. 11-53.

4930th TEST SUPPORT GROUP:

- 1. As a minimum, operate and maintain four (4) H-19B helicopters, six (6) L-20 aircraft and two (2) C-47 aircraft.
 - 2. Provide for the following:
 - a. Inter-island air transportation.
 - b. Airways and Air Communications Service (AACS).
 - c. Weather service.
 - d. Airbase facilities.
 - e. Maintenance of stored Air Force equipment and supplies.
 - f. MATS air passenger and freight terminal facilities.
 - 3. Retain overall control of SAR operations.
- 4. Prepare, coordinating with CTG 7.2, and implement a plan for storage of Air Task Group equipment and for basing the reduced air detachment.
 - 5. Operate POL and fire fighting facilities on ENIMETOK ISLAND.
- 6. Prepare to implement on order CTG 7.2 Natural Disaster Defense Plan No. 3-54 and CTG 7.2 General Emergency Operation Plan No. 11-53.

AEC BASE FACILITIES GROUP:

- l. Operate, manage, direct and maintain camp facilities at ENI-WETOK ATOLL, less facilities on ENIWETOK ISLAND herein charged to the Armed Forces.
- 2. Assume responsibility for construction of all base facilities required by the AEC for military and AEC support of test operations.
 - 3. Provide intra-atoll surface lift for the garrison.
- 4. Provide marine craft and craft operators for loading and off-loading supplies and equipment from ship to shore.
 - 5. Except on ENIWETOK ISLAND, carry out onshore cargo handling.
 - 6. Operate POL Farm on PARRY ISLAND.

TG 7.2 Boat Pool.

- 8. Insure radsafety of AEC contractor personnel and assume residual radsafe functions except on ENIWETOK ISLAND.
- 9. Conduct necessary liaison with CTG 7.2 to insure coordinated effort in the defense against hostile action and natural disaster.

INTELLIGENCE, SECURITY AND PUBLIC INFORMATION

1. INTELLIGENCE - GENERAL:

- a. No interference with the mission of Task Group 7.2 is expected from an overt enemy action during the interim period following Operation CASTLE.
- b. The USSR and its satellites have given no indication of relaxing their drive toward world domination and are maintaining an advanced state of preparedness for war. An overt war with the Soviet Union would be on a global basis and would involve forces in the ENIWETOK area.
- 2. SUMMARY OF ENEMY CAPABILITIES: It is considered that interference with the mission of Task Group 7.2 or compromise of activities within ENIWETCK ATOLL could be effected by espionage, sabotage, overt action by vessel or aircraft, raids, observation, unauthorized sampling and declaration of war.
- a. <u>Naval Capabilities</u>: Due to the isolation of the ENI-WETOK area surface action is discounted as a means of attack by an enemy in this area. It is estimated that 4-6 ocean patrol submarines could be maintained in the ENIWETOK area indefinitely and this number could be increased for short periods of time. Unobserved submarine approach to within one mile of the atoll is possible.
- b. Ground Capabilities: No ground capabilities exist for any potential enemies in the ENTINETOK area. It is conceivable that small raiding parties, either air or submarine transported, could operate in the area for short periods of time.
- c. <u>Air Capabilities</u>: Aerial photo and radiological reconnaissance missions over the ENIWETOK area from SAKHALIN or the KURILES are within Soviet capabilities.
- 3. CONCLUSIONS OF ENEMY CAPABILITIES: Espionage, sacotage, observation and unauthorized sampling are considered most likely to occur under conditions existing today. In the event of general hostilities, action by the enemy in the ENIWETOK area would consist initially of the following, in the order of probability:
- a. Raids and possible landings by small forces of enemy personnel from submarines.
 - b. Aerial reconnaissance.
- c. Attack by armed aircraft to include possible paratroop landings.
- 4. ESSENTIAL ELEMENTS OF INFORMATION: All JTF SEVEN personnel in the ENTYETOK area will advise CTG 7.2 of:
- a. Any information that air or surface craft are within the ENITETOK Closed Area as defined in paragraph la (3), this order. This information will include where possible:
 - (1) The number and type of craft, markings and identity.
 - (2) Location, speed and direction of movement.

Annex C to CTG 7.2 Operation Order No. 2-54 (Cont'd)

- b. Any information which casts doubt on the loyalty and/or character of JTF SEVEN personnel or indicates that such personnel are not good security risks.
- c. Any information which indicates the possibility of sabotage of materials or equipment.
- d. Any information which indicates possible espionage efforts.
- e. Any information which concerns the interference or possible interference with Task Force activities by unfriendly forces, to include capabilities, actions and intentions, if known.
- f. Any information which indicates the presence of unauthorized persons in the Forward Area.
- g. Any security violation or suspected security violations occurring within ENIWETOK ATOLL.

5. SECURITY RESPONSIBILITIES:

- a. All Detachment Commanders TG 7.2 are responsible that:
- (1) A unit Security Officer is appointed on orders, whose primary duty shall be to assist and advise the commander on matters of security and establish close liaison between the unit and the TG 7.2 Security Officer.
- (2) A comprehensive continuing security training program is conducted for all individuals within his unit.
- (3) Periodic inspections are made to insure that no items of contraband as described by CINCPAC Serial 020, dated 1 April 1952 are present in his unit area.
- (4) All classified documents and/or material for which he is responsible are safeguarded in accordance with AR 380-5 and SOP 11-20, CTG 7.2.
 - b. The Military Police Detachment, 7126 AU will:
- (1) Conduct monthly ground security sweeps of designated islands of ENIWETOK ATOLL. (See SOP 125-2, CTG 7.2)
- (2) Conduct weekly air security sweeps of ENTHETOK ATOLL. (See SOP 125-2, CTG 7.2)
- (3) Provide sufficient personnel to insure the orderly processing of incoming passengers at MATS Terminal and to conduct a baggage search for contraband items under CINCPAC Serial O20. (See SOP 125-1, CTG 7.2)
- (4) Provide such security guards (in addition to normal interior guard requirements) as may be deemed necessary by CTG 7.2 for the protection of sensitive installations and/or materials.
- (5) Patrol the island of ENIMETOK by motor patrol 24 hours per day and be constantly on the alert for evidence of EEI as set forth in par 4, this Annex.
- 6. PHOTOGRAPHY: Only official photography is authorized in the ENIMETOK area. Official photographs may be requested and all film will be accounted for in accordance with CTG 7.2 SOP 205-12.
- 7. SECURITY VIOLATIONS: Unit commanders are responsible for investigating and reporting to S2, TG 7.2 all violations of security.

SIGNAL COMMUNICATIONS

- 1. PURPOSE: To set forth the communication mission required for support of garrison operations at ENIWETOK ATOLL during the interim period following CASTLE.
- 2. MISSION: Establish signal communications and service facilities required by the Forward Area garrison during the interim period.

3. TASKS FOR SUBORDINATE UNITS:

- a. Signal Detachment, 7126 AU:
- (1) Coordinate communication requirements for all elements of the garrison and submit projects for additional facilities requiring the requisition of fixed plant equipment to CJTF SEVEN for approval prior to implementation.
- (2) Implement communication projects as directed by CJTF SEVEN.
- (3) Maintain the ENIWETCK ISLAND telephone plant, to include periodic testing and maintenance of associated cable plant.
- (4) Operate and maintain the following high frequency radic communications circuits:
 - (a) ENIWETOK-USARPAC Duplex radio teletype.
 - (b) Ship-Shore (CW and voice).
- (5) Operate and maintain a communications center for TG 7.2, to include cryptographic facilities for all elements of the garrison. Provide local teletype service to Holmes and Narver Administrative Office, PARRY ISLAND, and to AACS Detachment, ENIWETOK.
- (6) Service and repair all motion picture projectors in use or in storage.
- (7) Maintain Armed Forces Radio Station WXLE and Special Service radio receivers.
- (8) Maintain tactical radio sets utilized by TG 7.2 and provide maintenance assistance to other elements of the garrison as necessary.
- (9) Conduct scheduled surveillance and maintenance of equipment in dehumidified storage.
- (10) Maintain authorized stock level of replacement and repair parts for all items of signal equipment.
- (11) Conduct communications security training for all personnel in the Forward Area. Monitor TG 7.2 communications for security and procedural violations.
- (12) Conduct message drafting improvement programs for the command as required.
 - (13) Maintain the communications facilities aboard the Dadistrict 1

Naval Detachment AVR craft used in sea, air rescue operations, and provide technical support in the operation of such facilities.

- b. 4930th Test Support Group:
- (1) Operate and maintain ENIVETOK-KWAJALEIN HF RTT (MUX) circuit, radio aids to navigation and airport control facilities.
- (2) Conduct periodic checks and maintenance of Air Force communications equipment in dehumidified storage.
- (3) Procure, store, and issue supplies and equipment required for operation and maintenance of Air Force communications installations.





RADIOLOGICAL SAFETY

- 1. GENERAL: Residual radioactivity may remain in some areas of ENIMETOK ATOLL necessitating monitoring and control of personnel entering such areas. Travel control of personnel in contaminated areas will be a function of TG 7.5, however troops of the garrison entering such areas will in some cases require monitoring services performed by TG 7.2 radsafe personnel.
- 2. MISSION: Organize and develop a radsafe organization to accomplish the following:
 - a. Perform ground monitoring services as required.
- b. Conduct radsafe orientation of all Armed Forces personnel of the ENIWETOK garrison.
- c. Provide radiac equipment for TG 7.2 requirements including repair, spare parts and calibration facilities.

3. TASKS FOR SUBORDINATE UNITS:

- a. Unit Commanders will:
- (1) Appoint a unit radsafe officer and NCOs as indicated in Appendix I.
- (2) Submit a roster of radsafe personnel showing name, rank and serial number, to this headquarters, ATTN: Radsafe Officer. Notification of changes in personnel will be made immediately.
- b. The TG 7.2 Radsafe Officer will institute and supervise a program for the continuous training of radsafe monitors and for the orientation of all personnel in radiological safety.
- c. The TG 7.2 Signal Officer will maintain all radiac equipment.

Appendix - Radsafe Organizational Chart


