TWO AREAS ARE OF IMMEDIATE CONCERN CLN

A. IF A QUICK AND DIRTY DROP IS DEMANDED CMM THE TASK COMMAND SHOULD BE VESTED IN AN AIR FORCE COMMANDER OF SUITABLE RANK WHO COULD STAFF HIS ORG AT THE KIRTLAND LOCATION AND LOGISTICAL PROBLEMS WOULD BE RELATED ONLY TO MILITARY STAGING AREAS PD LIAISON ONLY WITH OFO WOULD BE NECESSARY PD

B. IF IT IS DETERMINED THAT PARRY SHOULD BE RE-OPENED AND OPERATIONS CONDUCTED FROM ENIWETOK MM THEN MAXIMUM DOD LOGISTICAL SUPPORT IS NECESSARY UPON REQ OF OFO PD THIS POSSIBILITY REQUIRES THE IMMEDIATE DESIGNATION OF A DOD LOGISTICAL SUPPORT COORDINATOR WITH WHOM OFO MAY COMMUNICATE IMMEDIATELY PD
