Murphy June 17 gave Asahi correspondent Suzukawa interview for attribution "American official". Following are main points by Murphy in answer questions:

1/ Specific US plans re Pacific Security Organization have not (repeat not) been formulated. ~~Do not~~ possibility Japan would be invited participate "remote".

2/ US has received no (repeat no) Japanese proposal for formal consultation re Japanese economic situation. Subject discussed Mukai and others. US of course concerned and desires be helpful.

3/ US officials fully understand reasons Yoshida trip postponed and desire see Yoshida when he can come.

4/ Diet disturbance not necessarily reflection on Japanese parliamentary Government but merely single incident of type which occurs elsewhere.

5/ US closely following condition injured fisherman and have agreed in principle make compensation despite concern over lack of firsthand information on injuries sustained.

6/ No significant change US view re war criminals and Ryukyus and Bonins. Would appreciate report any Asahi reaction this interview.

Accordingly, recommend you make no further effort for conference with Japanese. Suggest you and Donaldson take week or ten days trip and see something of islands as tourists from respective universities. If no further initiative on part Foreign Office following your return Tokyo, may recommend you return US with view conference will not be held near future. Recommend you give Japanese scientists whatever unclassified information is available.

FOR DR. BOSS FROM DR. BUGHER

Agenda suggested conference (Embassy telegram 3095, June 11) implies satisfactory exchange with Japanese of information on fisheries matters by Boss and Donaldson. Therefore, assume U.S. responsibility this area (Department telegram 2510) satisfactorily discharged. Scope proposed agenda quite different from that originally contemplated. Material of all three items mentioned in agenda was discussed with Japanese by Dr. John Harley and Mr. Merrill Eisenbud, AEC representatives who were in Japan in January and April respectively. It would require time arrange participation in more extended discussion these same matters. Recommend no commitment be made for date on conference. Preferable that such conference, if deemed desirable, be held after settlement of claims. This would allow time for further study of agenda.

Pending establishment firm date for conference we will provide to Japanese various documents and publications bearing on subjects of suggested agenda so as to accelerate exchange of scientific information.

You should provide representative at forthcoming working group meeting on proposed NATO Medical Committee. Following are preliminary comments interested agencies on terms reference set forth AC/23(MC)WP/1:

Believe Committee should be under Committee on Civil Organization in Time of War. This arrangement would accord equal status to Medical, Civil Defense and Refugee Committees, facilitate coordination among them and avoid burdening Council with matters of detail. Assume SHAPE will be represented on Committee.

Assume Committee is to consider both military and civilian requirements in carrying out studies listed Parts I and II.

Part III should not be restricted to problems arising from special weapons casualties. Should also provide for study methods continuing normal public health services such as sewerage, water purification, food sanitation and continuity of routine medical services to sick persons.

First sentence Part IV would give Committee too broad a mandate and second sentence might preclude consideration problems submitted

submitted directly by SHAPE. Suggest Committee be empowered consider such other medical problems related to wartime planning as it seems necessary, as well as problems referred to it by other NATO Committees or by SHAPE through his representative on the Committee.

Since Committee will apparently have very heavy workload, you should obtain views other delegates regarding organizational questions such as necessity technical secretary and staff, frequency meetings, methods of carrying out Committee assignments, and type and level of representation.

Assume membership on Committee implies no commitment of national resources. Hope Committee activities will be unclassified as far as possible.
