C. FODNA IS FURNISHING FACILITIES, UTILITIES, AND MEDICAL SUPPLIES FOR MEDICAL-DENTAL SUPPTRT BY THE USAF MEDICAL TEAM WHILE USAF IS PROVIDING A TEAM OF MILITARY PERSONNEL. PL94-367 PROVIDES THAT MILITARY SERVICES SUPPORT SHOULD BE FURNISHED TO THE PROJECT WITHOUT REIMBURSEMENT.

2. RECOMMEND WAIVER OF FEATIMENT PROVISIONS OF AFR 168-6 BE DESTAINED FROM HQ USAF/SGHC/SGHXO TO PERMIT MEDICAL-DENTAL SUPPORT BY THE USAF MEDICAL TEAM AT ENEMETAK FOR PERSONNEL ASSIGNED TO THE ENEMETAK CLEANUP PROJECT, INCLUDING DOD CONTRACTOR PERSONNEL, ERDA
