SUBJECT: ENIWETOK PLANNING

1. BASED ON CONVERSATIONS WITH MR. ROGER RAY OF YOUR OFFICE, I REQUEST THAT YOU TAKE ACTIONS NECESSARY TO SUPPORT AEC HEADQUARTERS IN PREPARATION FOR AN INTERAGENCY MEETING ANTICIPATED IN LATE AUGUST TO DISCUSS CLEANUP OF ENIWETOK AND ITS RETURN TO ADMINISTRATIVE CONTROL OF THE TTI AND SUBSEQUENTLY TO THE ENIWETOKISE. YOU ARE ALSO REQUESTED TO ASSIST IN DEVELOPING OPTIMUM COORDINATED PLANS RELATED TO AEC PARTICIPATION IN SURVEY AND CLEANUP OF ENIWETOK ATOLL. IN THIS CONNECTION IT MAY BE ASSUMED THAT THE RADIOLOGICAL SURVEY CURRENTLY PLANNED BY DOS FOR SEPTEMBER-OCTOBER 1972 WILL PROVIDE AN ADEQUATE INITIAL BASIS FOR CLEANUP PLANNING.
