The following information is furnished as a basis upon which the Joint Task Force may prepare a reply to the letters from Corporals and dated July 2, 1954 and June 24, 1954, respectively.

Items in subparagraphs a, b, and e of paragraph 3 of the above letters are considered unclassified information. Item 3d is classified as Confidential, Restricted Data and may be discussed only with properly cleared personnel. Item 3f is at present being treated as Confidential information by the Surgeon General, U. S. Army who has custody of the clinical records of the personnel in question. The Atomic Energy Commission has no objection to downgrading item 3f to unclassified if competent authority desires to do so.

In connection with item 3c, the Atomic Energy Commission believes that much information concerning the actions taken by 7.4 to evacuate personnel from Eniwetok is unclassified. However, it is undoubtedly true that certain details with which the Commission is not familiar may be of a classified nature. It is believed that with respect to this operational aspect of the problem, the Task Force is in a much better position than the Commission to evaluate matters of classification. The Commission would, of course, be pleased to assist in any manner that we may on this point.

It is suggested that any reply which is directed to Corporals and be forwarded through the Commanding General of the Signal Corps Engineering Laboratories at Fort Monmouth under whose command the 9471 TSU is understood to operate. As a means of protecting Corporals and from inadvertently divulging classified information to their uncleared civilian

radiation exposure of United States weather personnel during CASTLE is forwarded for your signature as recommended by the Division of Biology and Medicine.

Dr. Bugher has previously discussed with the Chairman the possibility of legal action by Corporals and (the two weather personnel concerned). Although it is not known on what basis they might bring a suit against the United States, the repercussions that legal action might generate are considered to be of sufficient significance that this matter should be brought to the attention of the Commissioners.

1. The undersigned, Corporal participated in Operation CASTLE, conducted by Joint Task Force Seven, Task Group 71., Task Unit 13, Project 6.6, during the period 1 January 1954 to 15 May 1954.

2. During the course of my activities on Operation CASTLE, I was stationed on Eniwetak Island of Rongerik Atoll. On 1 March 1954 while I was on Eniwetak Island, I was subjected to radioactive fall out as a result of the thermonuclear explosion of 1 March 1954.

3. I would like to know if the following incidents are now considered unclassified, and if it is permissible for me to discuss them with civilian counsel:

a. That I was stationed on Eniwetak Island of Rongerik Atoll at time of radioactive fall out.

b. The amount of time spent on the island from the beginning of fall out to the evacuation from same.

c. The events, details, and actions taken by Task Group 7.4 and those in authority on Eniwetak Island of Rongerik Atoll concerning the evacuation of personnel from said island.

d. The amount of radioactivity the island was subjected to during the period 1 March 1954 to 3 March 1954.

e. The evacuation destination and the medical action taken.

f. The amount of radioactive contamination exposure recorded on my medical records.
