



That the Energy Research and Development Administration of the United States government assume full responsibility for medical treatment of radiation victims on Rongelap and Utirik Atolls.


1 IT IS REQUESTED by the Marshallese people through their
 2 Marshall Islands Nitijela Inits 24th Regular Session, 1977, that the
 3 Energy Research and Development Administration of the United States
 4 government assume full responsibility for medical treatment and care
 5 of radiation victims on Rongelap and Utirik Atolls; these victims
 6 shall be treated in facilities on the Mainland United States and not in
 7 Hawaii; that Assistance in any way or requirement for any purpose
 8 be uniformly applied per stirpes to the Rongelapese and Utirikese,
 9 be they are direct victims of fallout, after-fallout victims or a
 10 control group; and

11 IT IS FURTHER RESOLVED that certified copies of this
 12 resolution be sent to the Director Energy Research and Development
 13 Administration, United States; to Cyrus Vance, Secretary of State,




A RESOLUTION

That the Energy Research and Development Administration of the United States government assume full responsibility for medical treatment of radiation victims on Rongelap and Utirik Atolls.


1 IT IS RESOLVED by the Marshallese people through their
 2 Marshall Islands Nitijela in its 24th Regular Session, 1977, that the
 3 Energy Research and Development Administration of the United States
 4 government assume full responsibility for medical treatment and care
 5 of radiation victims on Rongelap and Utirik Atolls; these victims
 6 shall be treated in facilities on the Mainland United States and not in
 7 Hawaii; that Assistance in any form or requirement for any purpose
 8 be uniformly applied per stirpes to the Rongelapese and Utirikese,
 9 be they are direct victims of the fallout, after-fallout victims or a
 10 control group; and

11 IT IS FURTHER RESOLVED that certified copies of this
 12 resolution be sent to the Director, Energy Research and Development
 13 Administration, United States; to Mr. Cyrus Vance, Secretary of States,
 14 United States; to Mr. Andrew Young, United Nations Ambassador, United
