


With regard to the forces to be maintained in a standby status, the appropriate members of the MLC stated that the Air Force component would maintain an experienced nucleus of approximately 50% present strength; that the Navy component would drop to a small nucleus of staff officers, from which it would be necessary to build up anew for a spring test; and that the Army component would retain adequate forces in a standby status for the spring test.



again that this latter test is only a possibility and definitely not a probability.

It was noted that the Executive Agency should be advised to plan for a test in the spring of 1954 and to maintain an emergency capability for a test in the fall of 1953.

Mr. Dean and Mr. Boyer stated that a letter to the DOD making a formal recommendation for the postponement of CASTLE is forthcoming and that it will request that the DOD provide for a possible move-up of the date of the test.
