MEMORANDUM for the Chairman

SUBJECT: INFORMATION GIVEN JOINT COMMITTEE RE CLEAN WEAPONS (u)

- Senator Pastori was the only member of JCAB who visited Proving Ground during Redwing. He was there from 6 to 10 May. He did not see a shot. Ogle gave a briefing Senator Pastori attended in which Ogle explained briefly that two tests were designed to test clean devices.

On 23 January 1956 I briefed the Military Application Subcommittee of the JCAB on Redwing. The briefing and questions thereafter lasted about two hours. I discussed each shot in detail and from charts which had columns showing purpose of each shot. Two devices were shown as designing to test the clean principle. Copies of these charts were given to JCAB staff for the record.

I had check made on Quarterly Report to JCAB where we reported plans for Redwing. Report concerned is that for period ending 31 December, 1955 and was apparently sent to JCAB in March. It contained a paragraph which explained a purpose of tests was to try clean principle and charts showing which devices were clean.
