Participation of Foreign Observers in Operation PLUMBBOB

1. The working group met pursuant to instructions from the CCB Executive Officer to consider the views of the Department of State and Defense with respect to foreign military observers at Operation PLUMBBOB and to formulate recommendations for the Board with respect to its decision of April 24 to limit official foreign military observers at the Nevada Test Series to countries in the North Atlantic Treaty Organization, the U.K. and Canada.

2. Working group considerations were subsequently set forth in a memorandum for the CCB, dated April 26, 1957, subject "Recommendations of the CCB Nuclear Energy Working Group with Respect to Foreign Military Observers at Operation PLUMBBOB (1957 Nevada Test Series)." The working group recommended that the CCB reconsider its decision of April 24 and concur in the view that invitations should go to countries already agreed by the Departments of State and Defense for the reasons set forth in the subject paper.

3. The AEC member reiterated the position previously taken by the Chairman, AEC, and reserved his agency's position with respect to the working group recommendations.

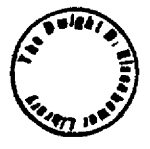
