SAIPAN, MAR, 21 (MNS) -- IN THE YEARS AGO, THE U.S. GOVERNMENT TOUD THE BIKINI ISLANDERS IN THE MARSHALLS ISLANDS IT WAS SAFE TO RETURN TO THEIR ATOLL, ONCE THE SITE OF NUCLEAR WEAPONS TESTS IN THE PACIFIC, AND SOME OF THE ISLANDERS WENT HOME.

NOW THE GOVERNMENT HAS FOUND THAT IT WAS WRONG, ACCORDING TO A WASHINGTON POST ARTICLE. TESTS CONDUCTED LAST YEAR REVEALED THAT THE GROUNDWATER IN BIKINI IS STILL TOO RADIGACTIVE FOR HUMAN CONSUMPTION, SO ARE COCOMUTS AND FRUITS AND VEGETABLES GROWN IN THE STILL CONTANINATED SOIL, THE WASHINGTON POST ARTICLE STATED.

INTERIOR OFFICIALS ARE ASKING THE U.S. CONGRESS FOR \$6 MILLION (SIX MILLION DOLLARS) IN FISCAL 1979 TO BEGIN A PROPOSED NEW \$15 MILLION (FIFTEEN MILLION DOLLAR) PROGRAM TO TRY AGAIN TO RELOCATE THE BIKINIANS WHO WERE MOVED OFF THEIR ATOLL TO MAKE WAY FOR THE NUCLEAR MEAPONS TESTS!

SOME THREE MILLION DOLLARS HAS ALREADY BEEN SPENT ON BRINGING THEM BACK TO BIKINI, THE ENTIRE ISLAND WAS PLONED UP, TOPSOIL REMOVED, 50 THOUSAND NEW COCONUT TREES PLANTED AND 40 NEW HOMES BUILT.

TRUST TERRITORY HIGH COMMISSIONER ADRIAN P. WINKEL SAID ON SAIPAN TODAY THAT THE STORY BY WASHINGTON POST IS "ACCURATE" BECAUSE IT WAS WRITTEN FROM REPORTS AND DATA SUBMITTED BY THE DEPARTMENT

OF INTERIOR TO THE U.S. CONGRESS!

WINKEL SAID THE PROPOSAL TO FUND THE MOVE OF THE BIKINIANS ONCE AGAIN TO ANOTHER ISLAND WILL BE SUBMITTED TO THE APPROPRIATIONS COMMITTEES OF THE U.S. SENATE AND HOUSE OF REPRESENTATIVES. (CRALEY ELECTED CHAIRMAN OF REFERENDUM BOARD)

THE BOARD PLANS TO MEET AS OFTEN AS NECESSARY BETWEEN NOW AND JULY 12, THERE IS ALSO THE POSSIBLITY OF HIRING A STAFF DIPECTOR TO BE LOCATED ON SAIPAN, CRALEY SAID HE HOPES TO UTILIZE THE RESOURCES OF THE CONGRESS OF MICRONESIA OR THE COMMISSION ON FUTURE POLITICAL STATUS AND TRANSITION.
