1. You are hereby authorized negotiate but not (repeat not) sign agreement with Japan in settlement all Japanese claims arising US 1954 nuclear test series. Settlement should be ex gratia, on most favorable terms obtainable, and should not in any case exceed one million US dollars.

2. For your information only, President on June 29 determined no more than one million dollars of MSP funds may be used pursuant Section 513(b) for this purpose. Because of technicalities connected and USFI cannot at present authorize you sign agreement but expect be able do so near future.
